

## **Campground Policies and Procedures**

### **PAYMENT:**

1. A (1) night non-refundable deposit is due within (7) days of booking the reservation, with the balance paid at the time of check-in.
2. If deposit payment is not received within (7) days from booking, reservation will be subject to cancellation.

### **CANCELLATION OR CHANGING OF DATES:**

1. Changes and cancellations may not be made unless permit holder notifies park reservation staff in writing at least (7) days prior to reservation date.
2. If a change in reservation is made within minimum notice period, there will be no penalty and payment/balance will be applied to a new date/s.
3. A request to change dates without appropriate (7) day advance notice will be equivalent to a cancellation and will result in the forfeit of payment.

### **OCCUPANCY: (ALL campers must register at Campground Office)**

1. **Check in 3PM; check out 11AM.** Notify park staff if you will be leaving before 6 am.
2. Only campers with reservations will be admitted after 8PM.
3. Campsites need to be occupied at night. Please notify staff if circumstances prevent you from occupying your site overnight.
4. **A parent/legal guardian over 21 must accompany all campers under 21 years of age.**
5. Maximum occupancy is 6 persons per site; maximum of 2 tents per site.

### **QUIET HOURS: (10PM to 6AM)**

1. All day visitors must leave the park by 10PM.
2. **Campfires are allowed in designated fire rings only** and must be extinguished by midnight.
3. **Campers failing to adhere to quiet hours may be asked to leave the park.** No refunds will be given.
4. When returning to your campsite after 10PM, please park in the boat launch parking lot and walk to your site. Park security will be happy to escort you if needed.

### **PARKING:**

1. **No more than 2 license plates are allowed per site.** Campers may receive car tags to park only one vehicle (car, truck, boat on a trailer, or motorcycle) on the site in addition to an RV, travel trailer or camper.
2. Additional permits for parking in the main beach parking area will be issued upon request.
3. No parking or driving on the grass.
3. Visitors must park in the main beach parking lot area.

### **VISITORS:**

1. Day visitors are welcome between the hours of 6AM and 10PM.
2. Day visitors will be charged regular park admission (\$7/vehicle during beach season).
3. Overnight guests will not be charged, but must register at the Campground Office upon arrival.

### **SECURITY:**

1. Oneida Shores is staffed 24 hrs during camping season. After hours park security (10PM to 6AM) can be reached by cell phone at (315)263-5606.
2. **The main gate is locked at midnight.** Please notify park security if you will be returning after midnight for access.

### **ALCOHOL:**

1. **There is a limit of one six pack (or the equivalent) per adult per day. No glass containers are allowed.**
2. We reserve the right to confiscate excessive amounts of alcohol, or alcohol possessed without a permit.

### **SANITATION:**

1. Restrooms are located next to site #1; showers and restrooms are located in the bathhouse buildings at the beach.
2. Restrooms and showers are locked for our campers' ease and safety. Combinations for the locks are on the camping permit.
3. The dump station is located near the entrance to the main parking lot.
4. Please wash dishes, etc. in the large sinks outside the restrooms. Please do not dump soiled water on the ground at your site.
5. **Campers must dispose of their own trash.** The dumpster is across the road from the campground entrance, towards the boat launch area.
6. Onondaga County is environmentally friendly-**WE RECYCLE!** However our dumpsters are co-mingled so all trash and recycling should be placed into the dumpster provided.

### **PETS:**

1. Household pets are welcome. **Campers must provide proof of rabies vaccination when registering.**
2. **Pets must be restrained by a fencing enclosure or on a six foot leash at all times.**
3. Pet owners must **clean up after your pets.**
4. Pets may swim off the campground point, or in Muskrat Bay area. Pets are not allowed on the playground, beach or in the swimming area.

### **COURTESY COUNTS!**

1. Clotheslines may be strung between trees and should not interfere with walkways or driving lanes. Be kind to our trees and don't use nails or tacks to hang clotheslines.
2. Keep **campfires in the fire rings provided. Do NOT bring pallets in to burn.**
3. Extinguish campfires thoroughly before leaving your site.
4. Please **observe the 5 MPH one way traffic flow** in the campground.
5. **No glass containers** are permitted in all of Onondaga County Parks.
